### History of Viewing Time Assessments

- ► First used by Rozenzweig, 1942
- Used by many researchers to assess sexual interest since then.
- First commercial use was a proprietary scoring and data interpretation system marketed by Abel Screening, Inc., 1996
- Several standardized systems available: Affinity, Limestone, LOOK

How to Measure Sexual Interest/Arousal

PPG- Penile Plethysmograph

VT- Viewing Time, VRT= Abel Assessment trademark (Visual Reaction Time)

# 3 Stages of Sexual Attraction in Males

Broadest- Sexual interest - Viewing Time

Middle- Moving toward the object of interest

Specific, Narrow- Sexual Arousal- PPG

(Singer, 1984)

#### **Psychometrics**

- Psychometric instruments are technologies that assist in decision-making
- People make decisions. Technologies don't
- Helps with major decisions:
  - Screening: What is a person interested in?
  - Diagnosis: What is the specific concern?
  - Prognosis: What is the predicted long term outcome?
- Does the data support our decision?

#### **Ipsative Testing**

- Each test is an experiment
- Finds baseline information for that individual
- Ipsative scores are frequently misinterpreted as norm-referenced.
- "Deviant" and "abnormal" assume that the scores are referenced to "normal"

#### What Are We Looking For?

- Deviant Sexual interests- Unhealthy
- Healthy Sexual interests
- Objectivity (what a client sexual interests are VS. Subjective, what a client says they are)
- Victim pool
- Used in combination with other know risks

#### We Assess Sex Offenders To:

- Determine risk/potential to re-offend
- Determine need for treatment
- Determine amenability & motivation for treatment
- Develop treatment issues, goals and plan
- Reduce the risk of re-offense

Research Based Risk Factors for Sexual Recidivism

3 of the top 12 risk factors for adult sexual re-offense:

Number 1) Preference for children

Number4) Deviant sexual preference

Number 12) Preference for boys

(Hanson & Bussière, 1998)

#### What VT does not measure?

- VT does not measure sexual interests to violence (PPG has a low/moderate ability)
- VT does a poor job of measuring many Paraphilias

VT does measure sexual interest across age ranges, race and gender

- Identifies Pedophilia
- Might identify Hebephilia
- Appropriate age sexual interests
- Unhealthy (deviant) sexual interests to younger children and older people

# Discussion with colleagues!

Based on early LOOK research, we found (unpublished) approximately 30% of non-offending people show sexual interests in children.

What is "Deviant" vs. "Unhealthy"?

A good tool promotes disclosure with clients

A process to talk with clients and learn more about their sexual interests and sexual history

#### Sexual Development


- Sexuality is not static, it is multidimensional and involves a developmental process that includes changes in our

- These occur as a result of human growth, from birth to death

#### Profiles to consider


- What we learn because of VT testing

- Imagine what is lost without Sexual Interest testing
- How does this guide evaluation and treatment

- If a healthy male, what would we expect?
- Interest in young adult females 20's -30's
- Some interest in mature adult females 40's- 50's
- Some interest in post-pubertal female teens (lower level than other categories



Expect a healthy male to show sexual interest in Mature Adult females, lowering Young Adult females and at lowest level Juvenile females. He identifies as Heterosexual.







